No permit shall be issued unless the applicant has first paid to the city the applicable fee required by one of the following:

| <b>(3) For erection of all billboards, display signs, roof signs exceeding 800 square feet.</b>                     | <b>\$150.00</b> |
| <b>(4) For erection of all electric signs not exceeding 32 square feet.</b>   | <b>\$50.00</b>  |
| <b>(5) For erection of all electric signs exceeding 32 square feet.</b>   | <b>\$150.00</b> |

In addition to the initial erection fees, the following annual inspection fees shall apply:

## BILLBOARD OPERATION – LICENSE

No person shall engage in the business of erecting, installing, servicing or maintaining display signs or poster or painted bulletins for rental or leasing purposes until such person shall have applied for and received a license to conduct such business and shall have deposited with the city an annual license fee in the sum of One Hundred Dollars (\$100.00). For the purposes of this Section, all such persons engaged in the business of erecting, installing, servicing or maintaining such display signs and billboards shall be designated "Billboard Operators".

All contractors that perform work inside the city limits are required to register with the City of Lindale. Registration issued shall expire at 12:00 midnight, one year from date of issuance, and shall be renewed on or before such date by payment of the prescribed fee of \$100.00, unless such license has been revoked or cancelled for cause.

### **ALL SIGN APPLICATIONS MUST BE ACCOMPANIED BY:**

Two (2) paper copies of Site Plan/Photo of Site (exact location of where the sign will be placed, exact sign proposed, dimensions, message, color, shape, and lighting). Sign permits expire a year (180 days) from the issue date if no progress is made on sign installation. No signs shall be installed until your permit is approved and a permit is issued. Any sign installed without a permit is subject to a penalty and the removal of sign at owner's expense. Signs may be required to have engineered drawings. All provisions of the City of Lindale codes, ordinances, and regulations will be complied with in the construction, alteration, or repair of said building herein specified or not.
